VI. GENERAL MANAGER'S REPORT

- Power & Water Resources Pooling Authority (PWRPA) A large rate increase is forthcoming as PWRPA expended more last year than anticipated. Despite this increase, PWRPA rates are still less than PG&E.
- Kings Basin Coordinating Committee recently held a managers' annual meeting. The Department of Water Resources determination on the Groundwater Sustainability Plan is pending.

Kyle Feitz, MS, PE, CalPoly/San Luis Obispo Irrigation Training & Research Center, appeared before the Board to review the "James Irrigation District SCADA Plan". The ITRC has recommended completing the expansion of long-crested weir installations across the District and

possibly adding selected Main Canal flow-rate controls (SCADA). Mr. Feist urged the District to proceed with caution with SCADA applications as "it must be done well to be effective". He also emphasized the continual high cost of SCADA O&M (estimated at 15% of purchase cost/installation annually). Estimated \$2-\$3 million for full implementation with uncertain labor savings. Mr. Feist indicated grants may be available through the USBR/WaterSmart and National Resource Conservation Service programs.

C. STRATEGIC PLANNING (02/08/2022)

Amy Wolfe, Mujeres Poderosas, LLC, reviewed her professional background and the methodology she utilizes to compile data for organizing a Strategic Plan. She estimated it will take three months to develop an action-oriented, flexible, 7-year plan. A period of inquiry/discussion followed.
