VI. EXECUTIVE DIRECTOR'S REPORT

Mr. Amorelli presented his verbal report as follows.

- ► <u>GROUNDWATER SUSTAINABILITY PLAN (GSP)</u>
 - Following submission of our revised GSP to the California Department of Water Resources (DWR) comments were received.
 - The DWR's decision on resubmitted GSPs is expected within the first quarter of 2023; the Kings Subbasin GSA is standing by until then.
 - An additional monitoring well is slated to be drilled at the southeast corner of Basin 3 in the James Bypass (Fresno Slough) and is currently under way.
- <u>GRANT FUNDING</u> is available to disadvantaged communities. The James GSA is less likely to receive funding this time based on their scoring metric.
- ► <u>KINGS RIVER CONSERVATION DISTRICT LOBBY EFFORTS</u> are trying to get all local GSAs involved.
