V. GENERAL MANAGER'S REPORT

Mr. Amorelli presented his verbal report encompassing operations, maintenance, projects and other District matters for the month of January, 2024, as follows:

OPERATIONS

- ▶ <u>Water Deliveries: January, 2024</u> Water deliveries for the month of January were an estimated 300 acre-feet which is 300 acre-feet more than was delivered during January, 2023. The fiscal year-to-date total deliveries are at 44,712 acre-feet which is 9,837 acre-feet less than was delivered at this time during the last fiscal year.
- U.S.B.R. / Central Valley Project
 - Allocations are expected to be announced February 21st.
- Kings River Water Association
 - <u>Pine Flat Flood Releases</u> are not anticipated this season due to low water content in the Sierra snow pack.
 - <u>KRWA Storage Operations in Pine Flat Reservoir</u> as of February 4, 2024, totaled 1,412 CFS-days.

PROJECTS

- Main Canal Feasibility Study Met with Dr. Charles Burt who recently retired from Cal/Poly and is now doing consulting work. Dr. Burt estimated \$60,000 to develop a plan for Main Canal improvements and will work with engineers.
- Community Solar Mr. Amorelli has been contacted by Vulcan Solar Power (VSP) for potential participation in Community Solar, a U.S. Department of Energy program that provides solar power to low-income families with solar arrays sited on ag land (5 to 20-acre parcels).

AGENCIES

- California Department of Water Resources (DWR) Met with DWR representatives exploring water banking, flood diversion & pumping issues during which MAGSA General Manager, Matthew Hurley shared various ideas.
- James Groundwater Sustainability Agency (James GSA) will be meeting February 15th.

LEGISLATIVE

Esmeralda Soria, Assemblywoman, District 27 visited the District February 10th to observe the District's K Basin Dual-Use Solar/Recharge Project. Mr. Amorelli took the opportunity to review the District's various water sources and Kings Subbasin water supply reliability issues. Local growers, landowners & community leaders also attended.

Reviewed a draft budget as predicated on 50,000 acre-feet sales, active solar, 30% CVP allocation, 100% rights water, at the current rate of \$140/acre-foot projecting a deficit of \$2 million. PG&E rates continue to escalate despite offsets from the solar power purchase agreement.

IX. REPORT ITEMS

A. SOLAR PROJECT: WHITEPINE RENEWABLES (03/09/2021)

Chris Woodington, Sr. Project Development Analyst for WhitePine Renewables, appeared before the Board to provide an update on solar Projects 1 and 2 in the Lateral K Recharge Basin facility.

- Project #1 was activated November 20, 2023, and is generating solar power as originally projected as well as recharging water.
- Project #2 is awaiting PG&E inspection/approval which is expected within the next 2-3 weeks.
- These projects will provide credits for 50+ well pumps. Mr. Woodington has been working with Mr. Amorelli and PG&E to evaluate how best to assign credits to wells. March, 2024, PG&E billings should reflect solar credits as a separate line item.
- ► Unused solar credits are banked and can be applied to other well meters. Credits can be re-allocated annually (March 1st) to reflect fluctuating hydrology.
- Solar credits are applied only against energy consumption, not demand charges. Installing battery back-up could reduce demand charges.

Mr. Woodington expressed his appreciation to the Board for allowing him the time to provide an update on the projects and then exited the meeting.
