# VI. EXECUTIVE DIRECTOR'S REPORT

Mr. Amorelli presented his verbal report as follows:

- Kings Basin Coordinating Committee Meeting weekly with representatives from the California Department of Water Resources (DWR) seeking their guidance in resolving deficiencies in the Basin's Groundwater Sustainability Plan. The DWR has requested clarification of water level data. Today's meeting will focus upon subsidence issues and interconnected waterways. Member GSAs are working together without conflict to satisfy DWR guidelines.
- ► Governor's Executive Drought Order / Well Permits

On March 28, 2022, California's Governor issued an Executive Order mandating GSAs approve agricultural wells. Residential/municipal wells that produce less than 2 acre-feet per year are excluded. Counties are currently working with GSAs to establish policies & procedures.
