V. GENERAL MANAGER'S REPORT

Mr. Amorelli presented his verbal report encompassing operations, maintenance, projects and other District matters for the month of February, 2023, as follows:

OPERATIONS

- Water Deliveries: February, 2023 Water deliveries were 934 acre-feet which is 3,163 acre-feet less than was delivered during February, 2022. The fiscal year-to-date total deliveries are at 55,484 acre-feet which is 112 acre-feet more than was delivered at this time during the last fiscal year.
- Kings River Water Association
 - <u>KRWA Storage Operations in Pine Flat Reservoir</u> as of February 26, 2023, totaled 4,299 CFS-days in Pine Flat Reservoir.

AGENCIES

- ▶ <u>James Irrigation District Annual Meeting</u> is scheduled for Thursday, March 30th. Reminders will be emailed to growers/landowners.
- ► <u>Kings Groundwater Sustainability Agency (Kings GSA)</u> The California Department of Water Resources approved the Groundwater Sustainability Plan (GSP) which is comprised of seven members' individual GSPs. Implementation is moving forward.
- McMullin Area Groundwater Sustainability Agency (MAGSA) Issues developed with initial start-up of booster pump which have been resolved. They are pumping from the James Bypass into their McMullin Grade lined canal onto Terranova land.
- Reclamation District No. 1606 Andrew Groppetti was recently appointed to the Board of Trustees replacing Wm. Cory Carvalho (Min: 02/20/2023).

ACTIVITIES

- Strategic Planning
 - Water Supply Committee met February 22nd and focused on three main issues:
 - 1. How to calculate/distribute water
 - 2. Tiered rates
 - 3. Distributing allocations to Reclamation District No. 1606 farm acres
 - <u>Infrastructure Project Committee</u> Dr. Charles Burt, Cal/Poly San Luis Obispo, is assisting. Evaluating the Main Canal. Grant funds are available. A multi-year plan will be developed.
 - <u>Infrastructure Maintenance Committee</u> Reviewed a list of District equipment, hours, purchase price for autos & pumps. Committee is scheduled to meet twice a year.

VI. SUPERINTENDENT'S REPORT

Superintendent, Kenneth Mancini, reported he and staff are involved in the following activities:

- Irrigations were started prior to rains but have slowed since then.
- Keeping basins full for recharge
- Working on office remodel (painting, flooring) in between rains.
- Working with Kings River on flood flows which have been erratic due to storms
- Maintenance, shop and repair work

PRESIDENT, RILEY CHANEY commented that he felt the recent Strategic Planning meeting of the Water Allocation Committee was very productive.

A. OPEN MEETINGS LOCAL AGENCIES: TELECONFERENCE - AB2449 (03/14/2023)

The Governor's Executive Orders N-29-20 and N-35-20 issued in response to the COVID-19 virus pandemic sunsetted January 1, 2023. To comply with the Ralph M. Brown Act, all meetings of the District Board must remain open to the public; however, AB2449 amended certain portions of the Brown Act relating to teleconference participation by members of legislative bodies in public meetings.

- ▶ <u>M/S/C</u> (M.COMBS / R.BARCELLOS), to <u>DISCONTINUE</u> internet access to the general public for Board meetings with the exception of Legal Counsel and/or consultants if warranted. C. WATER POLICY: ON-FARM RECHARGE (12/14/2021)

Discussed providing compensation to growers/landowners for on-farm recharge. The Board decided that water must be applied to *fallowed land only* and is not to be utilized for pre-irrigation/irrigation purposes which would allow a crop to be harvested or the District will demand return of payments.

M/S/C (R.MOTTE / W.CARVALHO):

- 1. Interested parties must apply to and be approved by the Board of Directors.
- 2. The District will make a maximum of 1,000 acre-feet available for on-farm recharge purposes.

D. FLOOD & EXCESS WATER DELIVERIES (03/14/2023)

Discussed the potential for deliveries of flood and excess water outside District boundaries.

- Andrew Groppetti noted in past years the optics of charging less for outside deliveries than was billed for in-District deliveries was not good. He was of the opinion that there should be no difference between the two rates.
- Director Robert Motte objected indicating he doubted excess flood water will sell at that price.

- 1. Charge the District's standard O&M rate (currently \$175.00/acre-foot) for flood/excess water exports;
- 2. The Grower/Landowner must bear the cost for set-up (berms, pipes, etc.); and
