V. GENERAL MANAGER'S REPORT

Mr. Amorelli presented his verbal report encompassing operations, maintenance, projects and other District matters for the month of September, 2023, as follows:

OPERATIONS

- Water Deliveries: September, 2023 Water deliveries for the month of September were 3,480 acre-feet which is 1,069 acre-feet less than was delivered during September, 2022. The fiscal year-to-date total deliveries are at 39,589 acre-feet which is 11,161 acre-feet less than was delivered at this time during the last fiscal year.
- U.S.B.R. Central Valley Project
 - <u>Mendota Pool</u> is slated to be dewatered from December 1-10 for maintenance of the dam structure as well as clearing sand deposits.
- Kings River Water Association
 - <u>KRWA Storage Operations in Pine Flat Reservoir</u> as of October 1, 2023, totaled 1,135 CFS-days
 - <u>Burford Family Farms</u> is receiving their Kings River entitlement through James Irrigation District facilities.

MAINTENANCE

- James Bypass / Water Hyacinth Kings River flood releases have stopped and the District is currently receiving its Schedule II/San Joaquin Riparian water. With this import, growth of water hyacinth has been observed migrating southward. Control efforts have been active north of Hwy. 180.
- ▶ <u>Weed Control</u> Met September 13th with our Simplot representative who plans to begin weed control applications mid-October.

AGENCIES

▶ <u>Kings Basin Coordinating Committee</u> met September 29th. California Department of Water Resources representatives participated remotely and were complimentary of the manner in which Kings GSA members have worked together.
